BUSINESS

- Education Programs
 - Ag Venture – HSWCD participated in the Ag Venture program at the Florida State Fairgrounds October 26 – 29 and November 1- 5, 2021, presenting multiple programs daily for public, private and home school students. A total of 821 students participated in the public/private school days with an additional 263 home school students. Presentations made by staff Tompkins and Collins, with Soil and Water station receiving the highest evaluation score of all stations. The Spring Ag Venture program will be held in April for a one-week period.
 - Fall Festival – Inaugural event held October 29 – 31, 2021 at the Hillsborough County Fairgrounds, which featured an array of old fashioned ag oriented activities. HSWCD participated with booth and hundreds of students made water cycle bracelets Event was both fun and educational for all involved.
 - Poster Contests – 2022 NACD Poster Contest – “Healthy Soil, Healthy Life” – Contest currently underway with participation expected from public, private, parochial, home and virtual students. Contest deadline: March 25, 2022.
 - Speech Contest - 2022 HSWCD Speech Contest – “Healthy Soil, Healthy Life” – Timetable to coincide with Poster Contest and printed materials being distributed.
 - Envirothon – Tampa Bay Regional Envirothon expected to return in 2022 with a live competition.
 - Land Judging – Competition will resume as a live event for 2021 – 2022.
- Director’s Report, review of Overall Programs- *Betty Jo Tompkins*
 - SECDEA – Tompkins attended Southeast Regional Employees Association meeting in Pigeon Forge, Tennessee (November 7 – 10, 2021) and gave 45 minute presentation on “Funding Streams: Maximizing Your District’s Potential” to entire Conference attendees. Received numerous requests for power point presentation, as well as copies of materials used in HSWCD programs. Tompkins and Chion developed additional materials for post Conference distribution.

Participated in Legislative Breakfast, Senate floor mock debate (Brookins & Tompkins debated), visited legislative offices, received Farm Bureau updates and participated with HSWCD booth in the “Fresh From Florida” reception, serving appetizers of Hillsborough County foods.

- NACD 2022 Urban and Community Grants – Grant Webinar – December 14, 2021 – Tompkins presented Hillsborough 100 Conservation Challenge program to national webinar.
- Resolution for HSWCD Participation in 2022 Urban and Community Grant Program.
- Hillsborough 100 Conservation Kickoff Luncheon – January 18, 2022 at The Regent. All aspects of event are currently underway, as well as planning for 2022 Challenge – April 17 – May 8, 2022.
- Florida State Fair – February 10 – 21, 2022 – Continued planning for HSWCD 30’ x 60’ complimentary exhibit space in the center of the Ag Hall of Fame for duration of the Fair. Exhibit theme will be: “Conservation is Everybody’s Business” and the exhibit will include painted characters of bees, bats, birds and butterflies (all pollinators), along with costumed live characters, exhibit pods on soils, water, air, forestry, recycling, conservation issues, etc. NRCS has agreed to provide \$3,000. in financial support for the exhibit and the Tampa Bay Beekeepers have agreed to purchase and wear a bee costume, as well as beekeeper outfit, for the exhibit. Exhibit will also include display of decorated rain barrels (from HSWCD contest at the County Fair), as well as blankets made of recycled material. Supervisors, staff and volunteers will be asked to volunteer at the exhibit during Fair. HSWCD will also participate in “Fresh From Florida” Breakfast (February 10, 2022), Governor’s Lunch February 10, 2022), Woman of the Year in Agriculture Luncheon (February 14, 2022) and Ag Hall of Fame Dinner (February 15, 2022).
- Florida Strawberry Festival – March 3 – 13, 2022 – HSWCD will participate with booth in Grimes Building, as well as Farm Credit Breakfast (March 7, 2022 and Grand Parade Luncheon (March 7, 2022).
- Lipman Garden Challenge –Planning for upcoming Challenge underway. This year’s participating groups, which will be the largest to date, will include school ag programs, science clubs, ESE classes, 4-H Clubs, Scouts and others.
- FDACS – Continuing work related to 2022 cost share contract (\$150,000).
- Continued writing articles for In The Field magazine and other publications.
- Visits to area agricultural operators to determine possible programs (HSWCD cost share or NRCS) they may be eligible to participate in.
